The USA Constitutional Crisis

- Precipitating a Coup Attempt
 - Shadow Government = Intel Agencies Operating outside Constitution
 - The Mainstream Media calls it the “Deep State”
 - A government operating within the legitimate government behind the scenes that the Mainstream Media does not report on or discuss in their newscasts, publications or even on their websites.

The “Deep State”

- Just who is the “Deep State?”
- Where did they come from and what are their goals and objectives?
- Can they be stopped?

The Beginnings of the “Deep State”

What is the Deep State?

- A Group of Individuals working behind the scenes to control all the governments of the world in order to create a New World Order!

Building the “Deep State” Model

- They began building their model after the Napoleonic Wars of 1799-1815.
- Napoleon destroyed the Holy Roman Empire and scrambled Europe.
- The “Deep State” needed to build their own country by uniting other small countries.
- When they succeeded with their model, then they could begin to do it on a large scale.

Building the “Deep State” Model

- It started prior to World War I
 - They needed to build a “laboratory country” to test their political and economic theories.
 - They needed to select a country to corrupt.
 - They wanted a country that did not have a long history or tradition of being together.
 - Until 1870, Germany was comprised of 42 City-States plus Bavaria and Prussia.
 - Their idea was to use the “Unification” of Germany as a model for creating a “new world order.”

Unifying 42 Nations into One Nation!




- The country was molded into its present state (1900) after the end of the Franco-Prussian War with Chancellor Otto von Bismarck as its leader.
- "Bulgaria, that little country between the Danube and the Balkans, is far from being an object of adequate importance... for which to plunge Europe from Moscow to the Pyrenees, and from the North Sea to Palermo, into a war whose issue no man can foresee. At the end of the conflict we should scarcely know why we had fought."

Creating a Power Base In Germany

- Once Germany was unified, it became the most powerful nation in Europe.
 - To placate many of the people who preferred to be separate, the German government began to socialize various parts of its economy. They passed socialized medicine at this time.
 - The Socialized programs cost so much that the German government was about to go bankrupt.
 - When the Archduke Ferdinand (successor to the throne of the Austria-Hungary Empire) was assassinated in Serbia while on a hunting trip, Austria declared war on Serbia. This kicked in several "entangling alliances."

The Map of Europe in 1900



Entangling Alliances

- The Franco-Prussian War of 1870 - Germany defeats France and captures Louis Napoleon III (Pictured to the right).
- The Dual Alliance of 1879 - Germany and Austria-Hungary made an alliance to protect themselves from Russia.
- The Franco-Russian Alliance of 1892 - Russia formed an alliance with France to protect herself against Germany and Austria-Hungary.
- The Triple Entente of 1907 - Russia, France, and Great Britain agreed to defend each other against Germany.



World War I

- When Austria-Hungary declared war on Serbia, this kicked in several alliances. Russia was obliged to help their fellow Slavs, while Germany was obliged to help Austria-Hungary. France and Great Britain were obliged to help Russia.
- For Germany, the War solved many of their economic problems. Wars put a lot of men to work as soldiers and other people to work to support the War. The additional economic growth supported a faltering economy for most of the war years.

Deep State Principle

- When a country's economy falters because of too much socialism, the only way to save that country is to start wars.

World War I Aftermath

- Russia dropped out of the War after the revolution in 1917.
- Even though Germany blew a hole through Allied lines in 1917-1918, the entrance of the United States into the War was more economic pressure than Germany and Austria-Hungary could handle. The Central Powers collapsed!
- The War ended in November of 1918 with the Kaiser Wilhelm II abdicating the throne and a civil war erupting.
- By February 6, 1919, a new constitution was adopted at Weimar, Germany and a parliamentary government was formed.

World War I Aftermath



- Germany continued to have economic problems, with the Papiermark, a paper currency created by the government to make reparation payments to the Allied governments.
- The inflation became so bad that it took a wheelbarrow of Papiermarks to buy a loaf of bread.
- In 1923, a new gold-backed currency called the Rentenmark was created to replace the Papiermark.
- The economic issues of Germany did not end with the issuance of new money.

The Weimar Government

- For most of the late 1920s, the Germany economy began to recover.
- The government used this wealth to initiate multiple social programs.
- The World Great Depression of 1929 took its greatest toll on Germany. This is the opening that the Nazi party and their “deep state” supporters were looking for.

The National Socialist Model

- Hitler's Nazi Germany was the first true “deep state” model!
- The *Schutzstaffel* or SS – was formed in 1925 as a “Protection Squadron” for Adolf Hitler
- The SS worked “behind the scenes” to get the National Socialist Workers Party (Nazi) enough seats in the Reichstag to force President Paul von Hindenburg to make Adolf Hitler Chancellor of Germany (effectively vice-president of Germany).
- They controlled the media (film, newspapers, radio).

The Reichstag Fire



- On February 27, 1933, six days before the parliamentary election, a fire broke out in the Reichstag chambers. Hitler immediately blamed the Communist Party of Germany for the blaze.
 - “The burning of the Reichstag was intended to be the signal for a bloody uprising and civil war. Large-scale pillaging in Berlin was planned for as early as four o’clock in the morning on Tuesday. It has been determined that starting today throughout Germany acts of terrorism were to begin against prominent individuals, against private property, against the lives and safety of the peaceful population, and general civil war was to be unleashed...”

The Reichstag Fire Aftermath I

- The German police caught Marinus van der Lubbe near the location of the fire and later determined he was the cause of the fire.
- Later police "Investigations" suggested that he took orders from four other Communists, but they were acquitted of any wrongdoing. He became the "lone nut arsonist."
- He was sentenced to death and guillotined on January 10, 1934.



The Reichstag Fire Aftermath II

- The real cause of the fire is still open to debate. Some argue that the Nazis started the fire as a “false flag” to gain votes in the upcoming election. The Communists were blamed and the *Reichstag Fire Decree* was passed:
 - On the basis of Article 48 paragraph 2 of the Constitution of the German Reich, the following is ordered in defense against Communist state-endangering acts of violence:

Reichstag Fire Decree

- Articles 114, 115, 117, 118, 123, 124 and 153 of the Constitution of the German Reich are suspended until further notice. It is therefore permissible to restrict the rights of personal freedom [*habeas corpus*], freedom of (opinion) expression, including the freedom of the press, the freedom to organize and assemble, the privacy of postal, telegraphic and telephonic communications. Warrants for House searches, orders for confiscations as well as restrictions on property, are also permissible beyond the legal limits otherwise prescribed.


Results of the March 5, 1933 Elections

- The Nazi Party did not win a majority of the seats, so they had to form a coalition with the German National People's Party, which shared many of the same ideals as the Nazi Party. That coalition gave them 340 seats or a 53.7% majority.

Paul von Hindenburg Wins!

- Field Marshal and World War I hero Paul Hindenburg was elected President by the Reichstag, but he could not do much ruling because the Nazi Party held too much power.



Hitler is Made Chancellor!

Because of the Power the Nazi Party Held, President von Hindenburg was forced to make Adolf Hitler his Chancellor (effectively his vice-president).



Paul Hindenburg signs the Enabling Act!

When Hitler got the Enabling Act of 1933 passed through the Reichstag, President von Hindenburg was politically forced to sign the bill. It is von Hindenburg and Vice-Chancellor Franz von Papen that support Hitler on their shoulders.

The Enabling Act of 1933

- After the Reichstag Fire, the Reichstag (meeting in the Kroll Opera House) passed the Enabling Act giving the government power to enact laws without the approval of the Reichstag. This was not the first time the Reichstag had given the government this kind of power. They had done this several times prior.



The Enabling Act of 1933 II

- The Enabling Act of 1933 gave the government these powers for a term of four years:
 - Enabled government could create laws, decrees, and even sign treaties with other governments.
 - These laws could deviate from the constitution.
 - The Reichstag could not abolish these laws!
- This Act was renewed in 1937 and 1939 by a Nazi Reichstag.



The Results of the Enabling Act

- The Enabling Act allowed Hitler free reign over the lawmaking, management, and operation of the German Government. Following the lead of the United States, who created the FBI, Hitler created under Heidrich Himmler, the head of the SS, a National Police Force called the *S.S. Gestapo*.



Paul Hindenburg is Dead!

- With the death of Paul von Hindenburg, Adolf Hitler automatically assumes the presidency and with the Enabling Act of 1933 fully signed, he and his administration are able to do anything they want.

 - The Theosophical Society (Helena Blavatsky and Colonel Henry Steel Olcott)
 - Germanenorden (Order of Teutons)
 - Germanenorden Walvater of the Holy Grail
 - The Thule Society
 - The Vril Society (Built on the ideas of author Edward Bulwer Lytton)

The SS – A Government within a Government



- While the Schutzstaffel (SS) started out as Adolf Hitler's "Protection Squadron" in 1925. When Heinrich Himmler took the organization over, he turned it into the Shadow Government of Germany. It had these wings:
 - Waffen SS (Combat Units)
 - Allgemeine SS (Administrative-High End Research)
 - SS-Totenkopfverbände (Concentration Camps)
 - SS Gestapo (National Police Force)
 - SS Sicherheitsdienst (Security Service)
 - SS Ahnenerbe (Ancestral and Occult Research)

The Spiritual Power Behind the SS



Heinrich Himmler personally formed the Ahnenerbe SS to do ancestral research into Aryan roots of the Germanic peoples.

- Eventually, this research delved into studies of the pagan religions these Germanic tribes engaged in.
- Their research later studied the occult rites supposedly practiced by the Aryan "master race."
- In time, their occult research was being done at multiple concentration camps by members of the Ahnenerbe-SS. Wolfram Sievers, its leader was hanged after the Nuremberg Doctors' Trials for "crimes against humanity."



The Spiritual Power Behind the SS





- Heinrich Himmler believed in the “collective soul” concept. He believed that if he could collect enough worthy souls into the SS, the Nazis could effectively control the world.
 - After being put through a rigorous training regimen, young men and women were put through secret occult rites designed to make their adherents loyal to their death. As part of these rites, the initiates would give parts of their souls to the SS.
 - As these initiates were promoted, they went through even more rites, giving away even more parts of their souls.

The Spiritual Power Behind the SS




The Spiritual Power Behind the SS

- Only the Top Levels of the SS ever knew that they were giving their souls to the Devil.
- The SS began consulting with demonic spirits in order to obtain the technologies that would win the War for them.




The Spiritual Power Behind the SS

- By early 1943, the SS realized that the War was lost.
- Their disastrous loss at the Battle of Stalingrad which eliminated the Sixth Army, meaning they could not hold the Russian front together.
- The effective leadership of the SS was turned over to Martin Bormann.



Governing Nazi Germany

- The new effective head of the SS, Martin Bormann (understanding that the War was lost) began planning for the Fourth Reich AKA the "Deep State."
- After spending a year planning the "Deep State" out, Martin Bormann called for a special "high security" meeting of German leaders and businessmen at the Hotel Maison Rouge in Strasbourg, France on August 10, 1944.



Outlining the Fourth Reich

- At this tightly secured meeting in Strasbourg, France, one of Mr. Bormann's confidants: Dr. Otto Schied, an architect and entrepreneur outlined a program to establish a Nazi "deep state" New World Order.
 - Their most secret assets would be moved to Antarctica.
 - Other assets would be moved to Argentina, Chile, and Paraguay, where they would reinforce the existing German communities and set up new ones. The most infamous one was *Colonia Dignidad* (Dignity Colony) in Chile. It is now called *Villa Baviera* (Bavaria Village). The colony was run by Paul Schaefer, a former corporal.

Outlining the Fourth Reich

- Operatives of the SS would set up 750 new corporations around the world to move proprietary assets (including their untoward medical research from the Concentration Camps) into “neutral countries” so they would not be seized by Allied intelligence.
- Their nuclear research went first to Argentina and then to Paraguay and Chile after the 1955 Military Coup.

Outlining the Fourth Reich

- The SS would begin the process of covering up certain “war crimes” so that their scientists would be assimilated into the United States and Great Britain. The SS began the process of destroying the smaller concentration camps where specialized research was being done. The records would be burned and the victims were either sent to other camps for extermination or just killed and destroyed at that location.

Outlining the Fourth Reich

- He explained that they had made contact with Allen Dulles, an Office of Strategic Services operative. He was willing to work out a deal with the United States government to assimilate their secret agents working in Russia and Eastern Europe into the OSS.
 - The United States considered this deal a godsend because they had few assets and little or no operating capacity in Russia.

Outlining the Fourth Reich

- Dr. Scheid further explained that the SS had made a similar deal with MGB (forerunner of the KGB and SVR) concerning German agents in Great Britain and the United States.
- In this way, General Reinhard Gehlen could orchestrate a new "cold war" between Russia and the West using exaggerated reports of each other's capabilities.

Outlining the Fourth Reich


- Dr. Scheid then explained a plan to transfer rocket scientists like Dr. Werner von Braum to the United States while they transferred rocket technicians to Russia to further this "cold war."
- When Russia repatriated the rocket technicians back to Germany in 1952, the SS reassigned many of them to Egypt to build rockets to destroy Israel. The Mossad killed most of these technicians, either with "letter bombs" or by assassination.

Outlining the Fourth Reich

- To cover their tracks, they would continue to make it appear like Adolf Hitler was still in charge of Germany and still leading the Army, the Navy, and the Luftwaffe (German Air Force). They knew they had less than a year to get everything done that they wanted to do.
- When the War was over, they moved Hitler to Argentina where he relaxed the rest of his life. While Martin Bormann kept him apprised to what he was doing, it was clear that Hitler was NOT in charge.


From Nazi Germany to the USA

- OSS Agent Allen Dulles used his contacts in the U.S. Government to bring Nazi scientists into the USA under Operation Paperclip and Project Lusty.
- The Russian equivalent was Operation Osoaviaknim.
- The British equivalents were Operations Backfire, Surgeon and Fedden Mission.



Operation Paperclip

- Operation Paperclip was used to bring into the United States, multiple third and fourth level Nazis, to bring about the “Deep State” in North America.
- The Main Stream Media (MSM) continues to forward the narrative that Operation Paperclip only brought in “scientists” and reminds us of Dr. Wernher von Braun, who would later head up the National Aeronautics and Space Administration (NASA).
- What they neglect to mention is that he ordered death of enslaved factory workers building V-2 rockets who did not work as fast as he wanted them to.



Operation Paperclip

- Operation Paperclip would end up bringing in over 1,800 “scientists” to develop chemical and biological weapons, when many of them should have been tried for war crimes.
- Many of them were returned to Germany when it was determined that they did not have the kind of abilities the U.S. government needed.

Operation Paperclip

- The U.S. Government repatriated other Nazis working for their Propaganda Ministry to help our own government deal with its own media relations problems. The CIA program is called "Operation Mockingbird."
- When these Nazis came into the United States to help with Operation Mockingbird, they also brought their occult technologies with them in the form of subliminal advertising, media curses, and other control mechanisms designed to subvert the USA.

The Central Intelligence Agency

- The creation of the Central Intelligence Agency (CIA) in 1947 was designed to be a central repository for all intelligence information. However, when Satanist Allen Dulles took over the Agency in 1953, they started doing their own operations.




Operation Mockingbird

- One of those operations was Operation Mockingbird, designed to control the media determining what we are allowed to see and hear. They followed Dr. Joseph Goebbels' media control model to perfection.
- They designed the media to have a very few "choke points" to control the news.

Operation Mockingbird and Christianity

- In 1959, the CIA published (through the Brookings Institute), a study on how the Conservative Christian theology through the media needed to be controlled.
 - One of those ways was to install occultism into the churches and then use it to control and manipulate congregations.
 - They also used a lot of money to control a Christian publishing company, so they could promote their message.



Occult Propagation in the West

- With liberalism taking root in most mainline Christian church organizations, many of the people attending these churches turned to the occult for spiritual knowledge.
- Before long, they realized that obtaining occult power came at a cost.

Occult Propagation in the West

- Using recently obtained Nazi occult technology, the CIA started working to obtain control of the media, government, industry, and the religious structure of the USA and the rest of the West.
- When President Kennedy tried to dismantle the CIA, he was assassinated.

What has Happened to Our Country?
